## **Standing Committees - Overview**

The Board's primary role is to govern, provide leadership and direction for the Association in pursuit of the Mission. The role of each standing committee is to provide advice to the Board to improve its effectiveness to manage the affairs of the Association. Volunteers on Board Appointed Committees provide external expertise to support the Board to achieve the strategic goals of the Association.

**Governance Committee:** Assists the Board in determining and implementing an effective model of governance and in developing suitable governance policies for the organization.

**Audit & Finance Committee:** Assists the Board in carrying out its financial oversight responsibilities by performing monitoring, reviewing and advisory functions.

**Risk Management Committee:** Assists the Board in fulfilling its duty of care with respect to the safety and integrity of the operations of the Association;

- Identify potential and significant hazards and risks to the Association and makes recommendations to the Board to eliminate, mitigate or minimize such risks and hazards;
- Make recommendations to the Board in regard to actions to be taken and policies or procedures to be implemented regarding risk management for the Association.

**Nominations Committee:** Assists the Board in carrying out its internal governance responsibilities by developing and implementing effective plans and processes for the recruitment, nomination and orientation of candidates for the Board.

SSA Judicial Bodies operate independently from the SSA Board of Directors; SSA & Member Organization Directors, Officers, and Committee Members are not eligible.
